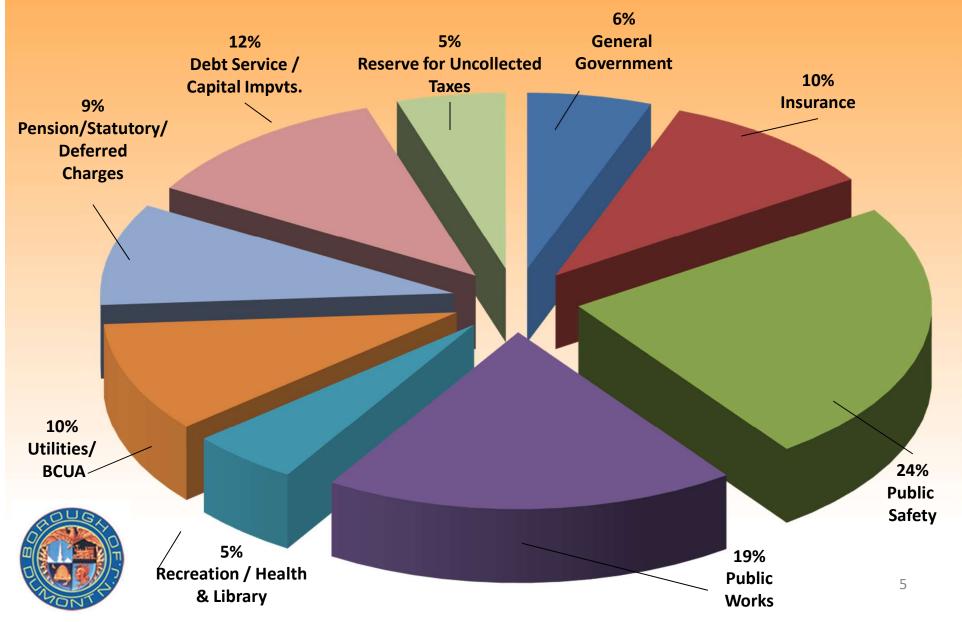

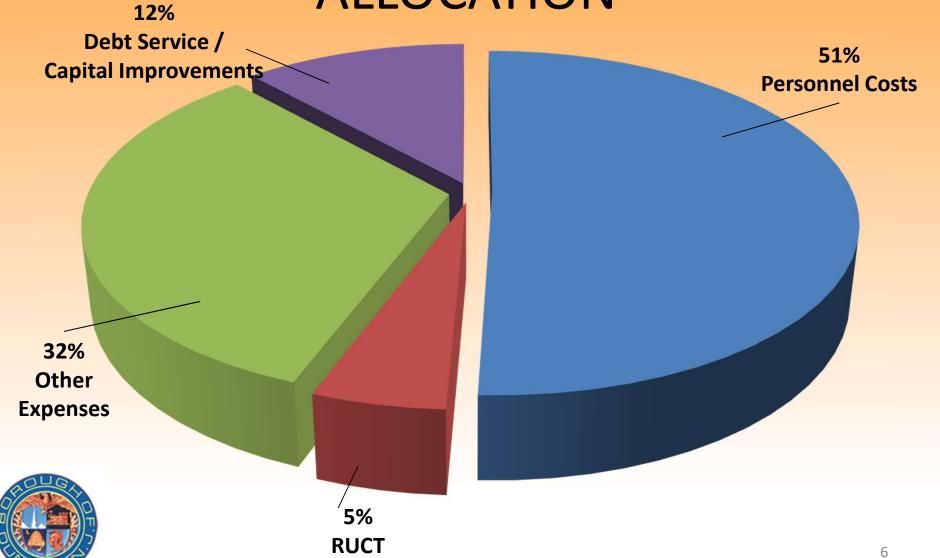

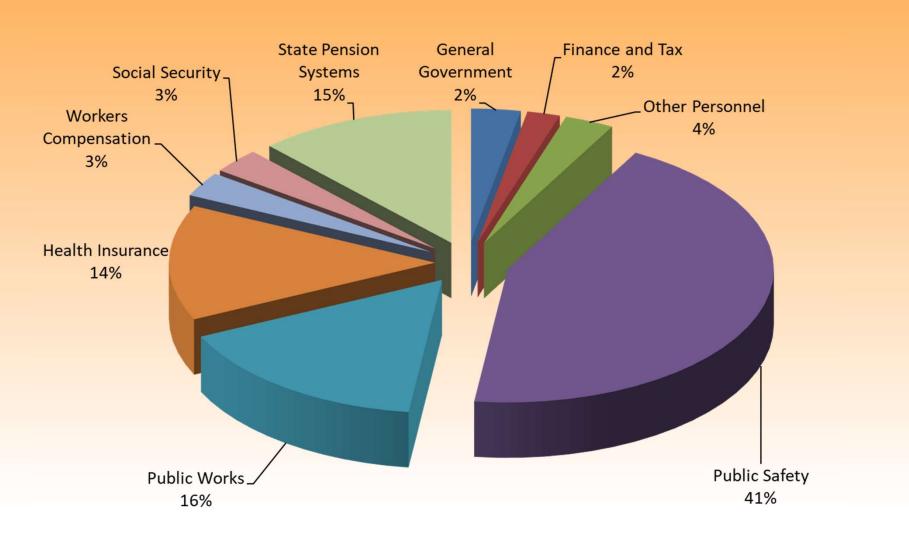
2021 APPROPRIATIONS BY FUNCTION



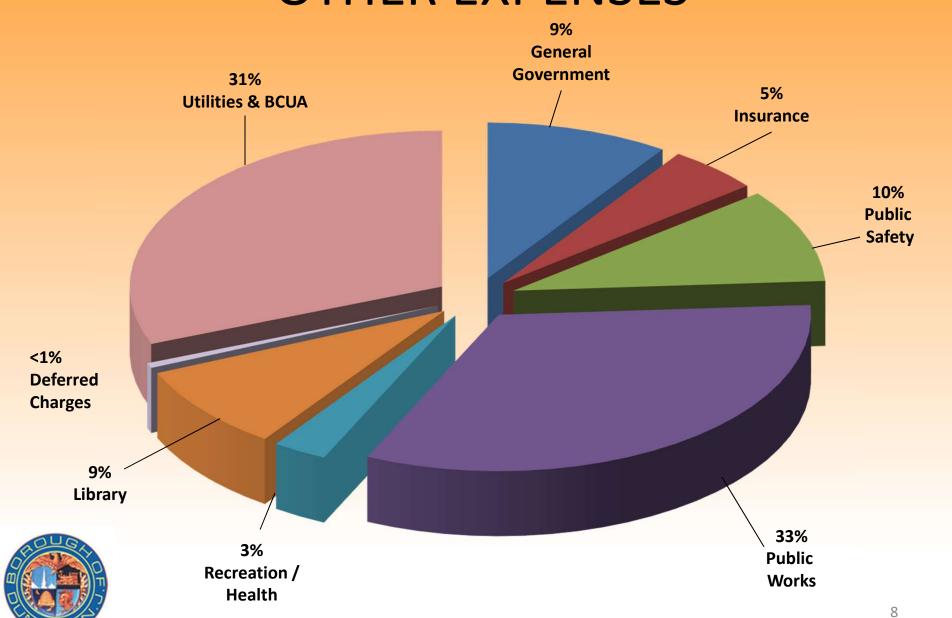
2021 APPROPRIATION ALLOCATION

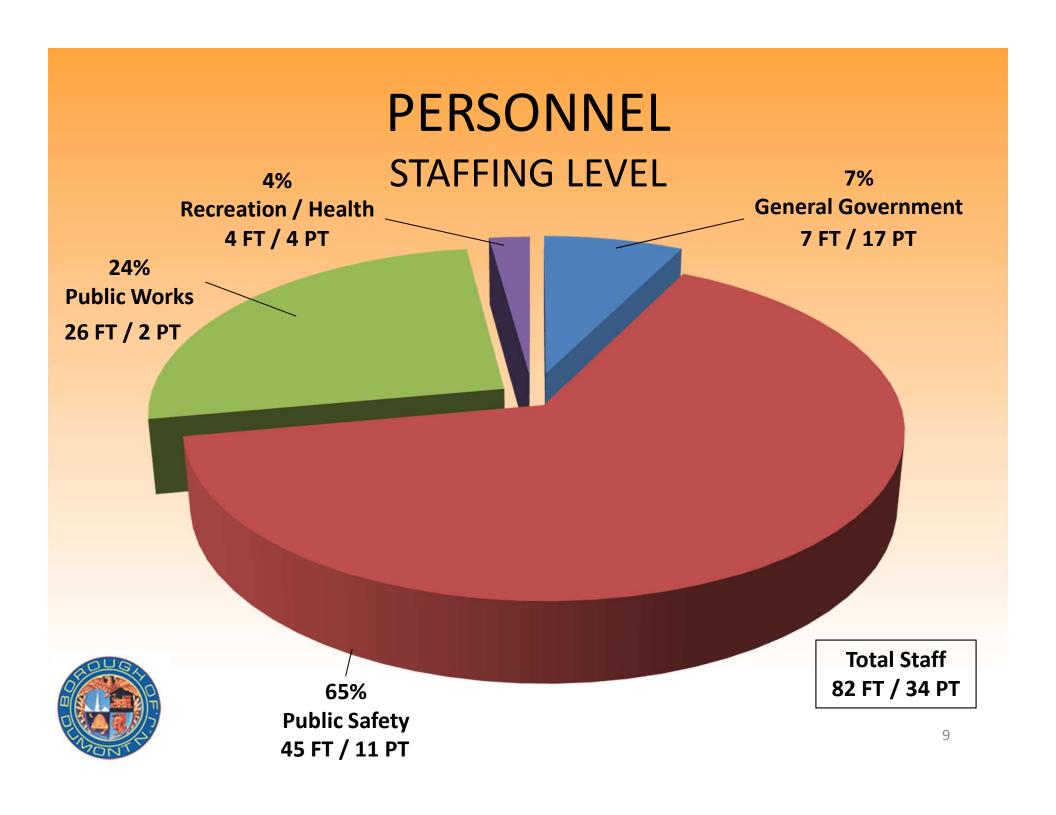


PERSONNEL COSTS
