AN ORDINANCE REPEALING PROVISIONS OF CHAPTER 69 OF THE BOROUGH CODE RELATING TO VACATIONS, PAID HOLIDAYS, SICK LEAVE AND GRIEVANCE PROCEDURES

WHEREAS, the Borough of Dumont ("Borough") has determined that changes are required to provisions of Chapter 69 of the Borough Code concerning Vacations, Paid Holidays, Sick Leave and Grievance Procedures; and

WHEREAS, the Mayor and Council have adopted a Personnel Policies and Procedures Manual that addresses, among other things, Vacations, Paid Holidays, Sick Leave and Grievance Procedures for Borough employees; and

WHEREAS, Borough employees who are covered by contract or a collective negotiations agreement remain subject to those contracts and agreements, as applicable, relating to Vacations, Paid Holidays, Sick Leave, and Grievance Procedures; and

WHEREAS, the Mayor and Council have determined that it is in the best interests of the Borough to repeal those Sections of the Code on Vacations, Paid Holidays, Sick Leave and Grievance Procedures that are covered by the Personnel Policies and Procedures Manual.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Dumont, in the County of Bergan, State of New Jersey, as follows:

- 1. Section 69-15 of the Borough Code be and is hereby repealed.
- 2. Section 69-16 of the Borough Code be and is hereby repealed.
- 3. Sections 69-26 through 69-28 of the Borough Code are hereby repealed.
- 4. Sections 69-53 through 69-56 of the Borough Code are hereby repealed.
- 5. Effective Date

This Ordinance shall be effective upon passage and publication as required by law.
