**ORDINANCE AMENDING CHAPTER 306-8 PROPERTY MAINTENANCE
OF THE DUMONT CODE**

An Ordinance of the Borough of Dumont, County of Bergen, State of New Jersey

WHEREAS, it is the express purpose of this ordinance to regulate parking in front of dwellings and to maintain consistency of regulation, and generally to promote, preserve, and protect the peace, good order, comfort, convenience, safety, and welfare of the citizens and inhabitants of the Borough.

THEREFORE, BE IT HEREBY ORDAINED by the Mayor and Council of the Borough of Dumont, in the County of Bergen and State of New Jersey, that Chapter 306, Section 8 PROPERTY MAINTENANCE of the Borough of Dumont Code shall be amended as hereinafter provided:


Paragraph A, Subsection 2 shall delete the word multi-family, or any reference thereto, from that section.

Invalidity. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.


Severability. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Effective Date. This Ordinance shall take effect upon final passage and publication pursuant to law.




