Formal action to be taken on the Certification of the School Tax Levy, deadline May 19, 2010.



CERTIFICATION OF SCHOOL TAX LEVY

WHEREAS, the school district tax levy for the General Fund portion of the 2010/11 budget of the Board of Education in the amount of \$31,900,326 was defeated by the voters of the Borough at the annual school election held on April 20, 2010, and

WHEREAS, pursuant to N.J.S.A. 18A:22-37, the Borough Council did receive the proposed school budget and supporting schedules and has consulted with representatives of the Board of Education to discuss the proposed 2010/11 school budget, and

WHEREAS, the Borough Council did review said 2010/11 budget and has identified

recommendations and justifications for reductions in the amount of \$1,000,000 in the General Fund budget tax levy for 2010/11 as detailed on Appendix "A", attached hereto.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Dumont does hereby certify to the Bergen County Board of Taxation, that the amount necessary to be levied for the General Fund budget to provide a thorough and efficient education for the Dumont Public Schools for 2010/11 school year is \$30,900,326.




