# AUTHORIZE COMMERCIAL APPRAISAL AND LITIGATION SUPPORT SERVICES McNERNEY & ASSOCIATES

WHEREAS, the Mayor and Council of the Borough of Dumont require the services of an appraisal professional to assist in defending tax appeals on behalf of the Borough; and

WHEREAS, from time to time it becomes necessary to prepare specific property appraisals to justify the assessed value in court proceedings; and

WHEREAS, a proposal was submitted by the Borough's duly appointed property appraiser, McNerney & Associates, for the required appraisal in the matter of <u>Dumont Terrace Apartments</u>,

<u>Inc. v. Borough of Dumont</u>, and the services having been deemed necessary by the Borough Tax Appeal Counsel and Assessor, and the Council concurring and seeking to authorize said proposal.

NOW THEREFORE, BE IT RESOLVED, the Governing Body of the Borough of Dumont, authorizes the preparation of a commercial property appraisal in the above captioned matter by McNerney and Associates Appraisers, in the amount of \$9,500, and additional litigation support as required at the rate of \$100 per hour in an amount not to exceed \$1,500, for a total authorization of not to exceed \$11,000 except on further action of the Borough Council, subject to certification of available funds by the Chief Financial Officer; and
