IN THE MATTER OF AWARDING CONTRACT FOR TELEVISED INSPECTION, CLEANING AND REPAIR OF SEWER SYSTEM TO NORTHWEST BERGEN COUNTY UTILITIES AUTHORITY UNDER EXISTING SHARED SERVICES AGREEMENT PURSUANT TO 40A:65-1 et seq.

BOROUGH OF DUMONT, COUNTY OF BERGEN AND STATE OF NEW JERSEY

WHEREAS, the Borough of Dumont has deemed it necessary to inspect, clean and repair, as necessary, the sanitary sewer system within the Borough, and;

WHEREAS, bids were solicited and received on January 8, 2015 for said project and were rejected as in excess of the Engineer's estimate and in excess of the available funds for the project by resolution #15-64 of February 3, 2015; and

WHEREAS, there is currently in force and effect an intergovernmental Shared Services Agreement between the Borough and the Northwest Bergen County Utilities Authority (NWBCUA); and

WHEREAS, a proposal has been tendered by NWBCUA to provide the requested services on January 19, 2015, at a price within the Engineer's estimate and available funding level, consistent with the existing Shared Services Agreement; and
