• Witnesses for Cingular Wireless:

John Post, Supervisor/General Manager, Commercial Tower North testified that the certified (Nat'l Association of Tower Erectors) pole climber under his supervision inspected and found conditions of existing antennas, hardware, measurements, openings and conditions of mounts were all satisfactory and up to all requirements. No recommendations for the tower.

Chris Scirrotti, Licensed Professional Engineer, Dewberry Engineers testified that the only active antenna today is Verizon at 110', but approvals are in place for one at 119' and one at 121', both marked T-Mobile. Once the pole is extended, AT&T would be the third carrier.

Motion to open to the public by Barbara Chen, Michael Cremin seconded.

All in favor

David Lee, One Tobin Court, Dumont questioned the impact of the wind on a fully loaded antenna at 150'. Question deferred to Mr. Post.

Bill Wicker, 4 Dance Boulevard, Dumont questioned who pays for the engineering and studies. It was established that AT&T is paying everyone. Concerns about aesthetics of the tower, could there be additional 'arrays' added. It was determined that there could not. Aesthetics are not usually taken into account, as they are towers, unavoidable in this day and age.

Motion made to close to the public by Michael Cremin Seconded by Joseph.Hakim All in favor.

John Yu, Licensed Structural Engineer, Dewberry Engineers, testified that no modifications are needed to the existing tower, which is at 96% capacity compared to percent of the land. The foundation needs to be modified by inserting steel rods into the bedrock to anchor it further. Mr. Yu clarified the question regarding wind speeds: tower was designed to withstand wind speeds of 105 mph, Risk Category 1, although Code says 98 mph.

Mr. Scirrotti testified that the foundation has a pier 23' x 23' by 3' thick. The rock anchor is drilled through that into bedrock 34' below ground and anchored an additional 13' of bond length into the rock.

Motion made to adjourn for 5-minute recess by Barbara Chen Seconded by Joseph.Hakim All in favor.

The only foreseeable change to this tower besides the standard full load, or 12 antennas, would be to the computer equipment. There is one mount across the 150' tower and each sector has four for a total of 12. The tower has been in place for less than 5 years. There are no plans for emergency communication as the police department has the main communication tower in town. The Boro Engineer, Boswell, has to sign off on this as well as the town building department as well as the construction engineers before this were to be approved.

Motion made to open to the public by Michael Cremin Seconded by Ken Armellino All in favor.

Dan Monti, 107 Second Street, Dumont

Mr. Monti had concerns regarding whether 105 mph falls within industry standard and the anchors will not be tied into a grounding system, as it is underground. Corrosion preventatives are in place and the life expectancy is 25+ years for the tower. The tower does not decrease in capacity over time unless it is damaged. There is an inspection of the tower every three years or after every hurricane.. The soil condition and anchor tension has been considered and there is no compression concern. There is a safety factor of two on this foundation, code is 1.5. Consideration given to the apartment complex nearby and possible EMF's and it is well within the federal limits. It is non-ionizing radiation, not like an x-ray.

Linda Lee, One Tobin Court, Dumont had concerns regarding stability, safety from ice. Drilling the platform does not make it less stable. 'Drop zone' for potential icefall is 150', as tall as the tower and it will be mostly confined the DPW yard. The possibility of earthquakes and hurricane's in north Jersey have been considered and it considered within safety limits.

Gary Vaccaro, 2 Tobin Court, Dumont

Had concerns regarding evergreen branches to make the pole more aesthetic. The pole was designed as a monopole, not monopine, so it cannot be done. Excel owns this pole and the board has no idea of the cost.

Dumont had the foresight to want all antennas in one place, and the DPW area was thought to be the best place, open fields around, least impact on area. Cannot hide a tower, they are a part of everyday life as over 40% of homes no longer have land lines, only cellular phones. This tower cannot go up any higher; this is the maximum. Governing body would have to approve.

Motion made to close to the public by Barbara Chen Seconded by Joseph Hakim seconded All in favor.
