Preliminary and Final Major Site Plan Application with Variances 112 Washington Avenue Block, 1214, Lots 3 and 4 MPMR, LLC

- Andy Del Vecchio, on behalf of the applicant, summarizes the prior presentations for the application.
- Mr. Del Vecchio discusses some of the changes to the revised plans.
- Mr. Del Vecchio calls Bill Vogt (planner) addresses the bus stop and other property issues. Mr. Vogt states that there have been discussions with Bergen County to move the bus stop and redesign it.
