#### **Open Public**

Dom Pierno, Mary Davis, Steve Valdez, Carlos Molina Michael Boyce Parents from Dumont girls' softball 3rd & 4<sup>th</sup> Grade team game to the meeting to discuss issues with DGSB, They wanted to know what they get for their \$200.00 registration fee. They also discussed that they were never told what the fee was. They were told several different numbers. Mary Davis said she was told \$250.00 she also said when she question it they said they would return here check she never received her check back Jamie O'Neill said that all the checks that were received were made out for \$200.00., Jamie said that he has copies of all the checks.

Don wanted to know why they did not know what they had to pay

Jamie stated that he assumed that everyone paid

Don stated that was unacceptable to allow that to happen

Jeff stated that the issues are the parents wanted to know what the right amount was what they get for the money. Jeff requested that Girls' softball supply an itemized list of What the cost are to play travel softball. The parents stated that there was no issue about paying they were waiting on the invoice.

Jimmy Reilly DGSB travel coach Jim stated that he has been a travel coach for many years and the Fee has always been \$200.00. Jim stated that the bags were bought for the first time last year

Rocco stated that the bags were bought last year because there was a surplus in the budget with the idea that there would be Minimal cost in futures to purchase bags for the new players to the program.

Gerry stated that in the future coaches will not be allowed to collect money or checks everything will go through Community pass all monies must be brought to the recreation office.

Jamie wanted to discuss a possible tournament dates this year May31st till June 2<sup>nd</sup> Dom wanted to know who controls softball funds

Gerry stated that the program controls their funds but they need to get major purchase approved by the commission.

Mike stated that we are meeting on Monday to try to finalized the plans for Gina's field And the backstop at twin Boro was moved back.

Michael stated that the girl's field are not in very good shaped

# Ken Sobek Flag Football

Stated that there's a lot od=f concern from parents, coaches, players about the status of flag football. For the coming seasons

Mike stated that it will be played in the summer and fall as previously discussed. Ken stated that the people in town want the 14 to 17 year olds flag program in the fall Corin Seccora

Wants to know why her son cannot play flag football in the summer and the fall Corin stated that there are ton of children going into high school that want to continue to play flag football her son will never play tackle football

Steve Orso stated that he has 2 boys under this plan one boy will play in the summer and one will play in the fall he stated that they both should be allowed to plat in each season. You will have multiple families in the same situation

Carole asked about how many kid would be playing in the fall Corin stated that a lot of the incoming 9<sup>th</sup> graders would play

Ken stated that at least 30 kids that he knows of. Ken also stated that putting a program in July would kill the program

Gerry stated the program was discussed it was decided that we would try it we asked Ken to help if he decides not we will still move on with program

Mike stated that when we discussed this with you we discussed that when registration for the fall we would add the summer program at a discount Mike ask ken if that was done.

Ken stated that he understood it to be the fall 2019 and the summer of 2020 Mike stated that the commissioner voted to have high school flag in the summer and not in the fall.

Corin Stated is there a way for the commission vote to be repealed

Gerry stated that you could appeal to the mayor and counsel. But the process will be sent back to the commission with their recommendations

Dennis Boos stated that another motion could be made to open the discussion for the program.

Corin made a motion to allow High School flag football in the fall of 2019 Motion was 2<sup>nd</sup> Mary Rodriguez

Asked when the commission voted to move the K thru 8<sup>th</sup> grade to the summer Gerry stated we will review the minutes and get back to him

Rocco stated that he wanted to inform the commission on the programs progress. The fee for 2019ll be \$230.00 up from last year's fee of \$130.00. The reason for the increase as they are purchasing new uniforms this year The kids are getting uniforms, warmups and bags Rocco broke down the pricing of each Item.

Rooco would to request from the BOE to allow them to put a banner in the gym to display their championships

Tony stated that he will try he explain that the town only pays bill once a month the next council meeting is on the 18<sup>th</sup> the bills list is publish the Friday before ED explain that the delayed in tryouts set the program back a month Gerry stated that if you could split invoices it could help the process
