### AUTHORIZATION TO HIRE AS DUMONT POLICE OFFICERS

WHEREAS, on March 7, 2017 Ordinance #1515 was adopted authorizing the Police Department to hire a PTC (Police Training Commission)-Certified applicants; and

WHEREAS, consistent with Ordinance #1515, the Dumont Police Department advertised for the position of police officer, seeking applicants with PTC Certification; and

WHEREAS, the Dumont Police Department accepted resumes in response to its advertisement; and

WHEREAS, resumes were reviewed and applicants interviewed by superior officers of the Dumont Police Department; and

WHEREAS, successful applicants of the departmental hiring phase were thereafter interviewed by the Chief and the Police Committee; and

WHEREAS, the Chief and the Police Committee have recommended the hiring of two (2) applicants who they deem to have the qualifications to be Dumont Police Officers; and

WHEREAS, Jesse Baiza and Kamal Elsayed are the top two (2) highest ranking candidates for police officer; and

WHEREAS, Jesse Baiza and Kamal Elsayed are PTC-certified; and

WHEREAS, the Chief and the Police Committee recommend the hiring of Jesse Baiza and Kamal Elsayed, subject to their full satisfaction of the conditions set forth in their conditional offer of employment letters; and

WHEREAS, Jesse Baiza shall be hired, subject to his full satisfaction of the conditions set forth in his conditional offer of employment letter, effective March 22, 2023 at a starting salary of \$51,665.00 (Step 3 on the PBA salary guide); and

WHEREAS, Kamal Elsayed shall be hired, subject to his full satisfaction of the conditions set forth in his conditional offer of employment letter, effective March 22, 2023 at a starting salary of \$51,665.00 (Step 3 on the PBA salary guide); and

**NOW, THEREFORE, BE IT RESOLVED,** the Governing Body of the Borough of Dumont authorizes the hiring of Jesse Baiza and Kamal Elsayed as probationary police officers in the Dumont Police Department upon full satisfaction of the conditions set forth in their conditional offer of employment letters, each to serve a 12-month working test period.

GRANTEE AUTHORIZING RESOLUTION - 2022 MUNICIPAL PROGRAM
PARK IMPROVEMENT PROGRAM – VETERAN'S MEMORIAL PARK FIELD
IMPROVEMENTS PHASE III - CONTRACT #2200348

**BE IT RESOLVED**, that the Mayor and Council of Dumont wish to enter into a Bergen County Trust Fund Project Contract ("Contract") with the County of Bergen for the purpose of using a \$87,038.00 matching grant award from the 2022 Funding Round of the Bergen County Open Space, Recreation, Floodplain Protection, Farmland and Historic Preservation Trust Fund ("Trust Fund") for the municipal park project entitled Veteran's Memorial Park Field Improvements Phase III, located in the Borough of Dumont, on the tax maps as Block 1006, Lot 1;

**BE IT FURTHER RESOLVED**, that the Mayor and Council hereby authorize the Borough Administrator, Chris Tully to be a signatory to the foresaid Contract; and

**BE IT FURTHER RESOLVED**, that the Mayor and Council hereby acknowledge that, in general, the use of this Trust Fund grant towards this approved park project must be completed by or about December 14, 2024; and

**BE IT FURTHER RESOLVED**, that the Mayor and Council acknowledge that the grant will be disbursed to the municipality as a reimbursement upon submittal of certified Trust Fund payment and project completion documents and municipal vouchers, invoices, proofs of the payment, and other such documents as may be required by the County in accordance with the Trust Fund's requirements; and

BE IT FURTHER RESOLVED, that the Mayor and Council acknowledge that the grant disbursement to the municipality will be equivalent to fifty (50) percent of the eligible construction costs incurred (not to exceed total grant award) applied towards only the approved park improvements identified in the aforesaid Contract in accordance with the Trust Fund's requirements. Professional Services Costs may be reimbursed from grant award's unexpended balance, should there a balance.
